

#### Temoor Ahmad Associate Grimshaw London, UK

Ahmad is an Associate at Grimshaw where he has been developing his field of specialty in infrastructure and the

associated potential for over-site development and place making.

He has worked in the UK, China, the UAE and Spain over a number of different sectors involving tall buildings where he has developed the belief that tall buildings are a key influence on a city's infrastructure. He will represent Grimshaw in a presentation on the value of incremental building to optimise density at the annual Council on Tall Buildings and Urban Habitat (CTBUH) conference in October.

Key involvement in infrastructure projects past and present in London include Paddington Crossrail, King's Cross Station, Euston HS2 and Waterloo Station. Temoor is also Vice-Chair of the CTBUH UK Chapter.



#### **Graham Barnes**

Before joining CBRE in 2001, Barnes qualified as a Chartered Accountant with KPMG and then spent 9 years




#### Ellen Brunsberg CEO and President, Europe GE Capital Real Estate London, UK

Moving to London in 1997, she created Morgan Stanley's industry leading European real estate lending for securitisation franchise. She earned a BS from MIT and an MBA from The Wharton Business School.



#### Professor Paul Cheshire Emeritus Professor of Economic Geography LSE London, UK

Cheshire works in urban economics and policy. He is an elected Fellow of

the Academy of the Social Sciences and of the Weimer School. He won the Royal Economic Society's best paper prize in 2005. He has acted as an advisor for the European Commission, the World Bank, the OECD, the UN and the UK government. Until its abolition in 2010, he was a Board member of the National Housing and Planning Advice Unit. He is a member of the DCLG's Planning Sounding Board and in 2013 was named one of the planning industry's 100 most influential people. His latest book is *Urban Economics and Urban Policy: Challenging Conventional Policy Wisdom*, Edward Elgar.



#### Christopher Choa Principal

> A native New Yorker, Choa is based in London and leads the urban development practice for AECOM.

He speaks frequently about the comparative advantages of cities, and works with city and national governments to develop regional-scale strategies.

A graduate of both Harvard and Yale, Choa serves on the UK executive board of the Urban Land Institute, and is on the external advisory board for the Sustainable Urban Development program at Oxford. He is an appointed member of the Mayor of London's Infrastructure Delivery Board.



#### Professor Greg Clark Senior Fellow ULI Europe London, UK

Clark is ULI Europe Senior Fellow where he builds intelligence on the dynamic trends between

cities, investors, and urban development. In addition to his work for ULI he is also Chairman, OECD LEED Forum on Local Development and Investment Strategies, Global Fellow, Metropolitan Programme, Brookings Institution, Chairman, JLL Cities Research Centre, and Visiting Professor, and Co-Chairman of Advisory Board, City Leadership Initiative, University College London.

He trained as an Economist, Social and Political Scientist, City & Regional Planner at Cambridge University, UK, Columbia University, NYC. He is a Harkness Fellow and author of ten books on cities, investment, and development issues.

Clark has advised on governance reform in London, Toronto, Barcelona, Auckland, Sao Paulo, Milan, and Oslo. He has led 27 Reviews of city and regional development for the OECD and has advised on national policies for 12 countries across the globe. He was recently awarded CBE by Queen Elizabeth for his contribution to economic development.

Clark has been with Linklaters

#### Isabel Dedring Deputy Mayor for Transport for London London, UK

Dedring is London's Deputy Mayor for Transport and Deputy Chair

of Transport for London. She is responsible for setting and delivering policy across the Mayor's £10 billion annual transport budget.

Dedring has led for the Mayor on a range of initiatives including the creation of TfL's £4 billion Roads Modernisation Programme and the Tube's 30% performance improvement target. She has been heavily involved in defining and delivering London's new air quality and cycling initiatives.

Dedring's role encompasses delivering new infrastructure, including through TfL's first "Growth Fund" designed to catalyse housing and jobs growth in London. Isabel also leads for City Hall on the Mayor's 2050 Infrastructure Plan for London. Dedring is a qualified US lawyer with a background in regulated industries and management consultancy.



Marnix Galle

ALLFIN London, UK

Galle started Allfin Group in 2001, where he is CEO and sole shareholder. Allfin quickly became

one of Belgium's and Luxembourg's leading developers, specialising in large mixed function urban schemes and urban reconversion. Since 2014, Allfin has been the reference shareholder of Immobel, Belgium's largest stock quoted real estate development company in the country. Galle completed a "Bachelor Degree in Arts & Sciences" in Economics as a major and Law as a minor at Tulane University (New Orleans, LA, USA). He began his professional career as a consultant in 1987 but soon switched to real estate. Galle is member of UPSI, RICS, and Chair of ULI Belgium.



#### Helen Gordon

Gordon is Global Head of Real Estate Asset Management (REAM) for the

Restructuring Group. REAM manages the West Register Portfolio.

Prior to taking on the role in October 2011 she was a Director of Legal and General Property responsible for the Main Life Fund and c.8 smaller Funds.

Gordon has held a number of non exec positions, Government appointments, and is currently on the Board of Covent Garden Market Authority and a Trustee for The College of Estate Management.



#### Sir David Higgins Chairman High Speed Two (HS2) London, UK

In 2014 Higgins was appointed the Chairman of HS2 as well as a Non-Executive Director at Australia's

largest bank, the Commonwealth Bank. Prior to this, Higgins held numerous high profile positions including Chief Executive of the Olympic Delivery Authority, English Partnerships and Network Rail Infrastructure Ltd.

Higgins graduated in Civil Engineering from the University of Sydney & holds a Diploma from the Securities Institute of Australia. Following graduation, he spent time working in the UK & Africa. He then spent many years at Lend Lease Group, where he was appointed Managing Director & Group Chief Executive in 1995.



#### Katrin Stjernfeldt Jammeh Mayor of Malmö Malmö. Sweden

Mayor Jammeh is a politician of the Social Democratic Party who has been the Mayor of the City of Malmö, Sweden, since 1 July 2013. She is

the first woman to hold the office in Malmö. She brings to this position a wealth of experience and has during her time as a politician consistently worked towards making sure that Malmö becomes a city where people of all origin and background can feel welcome and prosper.

Jammeh has a long past as a politician in Malmö, previously in charge of healthcare, school and education and as well welfare and security issues. Trained as a Political Scientist at Lund University, Jammeh has previously also worked as a communication consultant as well as a writer for a newspaper during several years.



## Dame Judith Mayhew Jonas

Mayhew Jonas is a ULI Trustee, was the founder Chairman of London & Partners, Chairman of the New West End Company, and is a Special Adviser to the US property company, Tishman Speyer. A City lawyer, she was the Leader of the City of London Corporation for 6 years and was on the main board of Merrill Lynch and the Wealth Management Advisory Committee at Barclays Private Bank.

Mayhew Jonas was deputy Chairman of the London Development Agency and was on the board of London First and London First Centre. She has served on and chaired numerous arts and educational institutions including being the first woman to chair The Royal Opera House, and currently chairs the Regeneration Committee of The Imperial Museum. She also chairs the British Dutch Dialogues and the London New York Dialogues.



#### Dr. Hans Koster VU University Amsterdam Amsterdam. The Netherlands

Dr. Koster's research focuses the economic analysis of cities, regions and the environment. Koster uses big data and advanced econometric

techniques to answer some of the cities' most pressing questions stemming from increasing urban population, competition for space, costs and benefits of land use regulations, investing public money in deprived neighbourhoods to reduce spatial disparities, etc.

Koster is affiliated as Research Fellow with the Tinbergen Institute and as Research Associate with the Spatial Economics Research Centre at the London School of Economics. He is an assistant professor at the Department of Spatial Economics, VU University Amsterdam. He obtained his bachelor's degree in Economics at the Erasmus University Rotterdam and his master's degree (cum laude) in Spatial Economics at the VU University Amsterdam.



#### Sir Edward Lister

Chief of Staff and Deputy Mayor of London, Policy and Planning London, UK

Sir Edward was appointed by the Mayor of London in May 2011 to co-ordinate implementation of the

Mayor's priorities, strategy and policy work. With the Head of Paid Service, he has responsibility for leading and overseeing City Hall and its budgets.

Sir Edward advises the Mayor on strategic planning applications, the London Plan and the Community Infrastructure Levy.

Prior to City Hall, Sir Edward served as leader of Wandsworth Council from 1992 to 2011.


#### Lisette van Doorn
